significance, the developer seeks not only to restore, but also to adapt the development for new market uses. The "3R" conservation principles of maximum retention, sensitive restoration and careful repair were employed. Adopting an exoskeleton approach, new structures and amenities were introduced to integrate "Old" and "New". Efforts were also invested to engage the local community to bring vibrancy to the precinct. Opened since 1999, Far East Square is a successful development that celebrates Singapore's heritage and modernity. It continues to refresh itself to maintain relevance in today's context. In 2012, the developer and two adjacent building owners initiated the China Square Precinct Master Plan to integrate the quaint charm of Far East Square and the bustling hive of retail and entertainment outlets next door. Launched in December 2013, AMOY, a 37-room designer boutique hotel, was converted from offices within the conservation shophouses to inject new vitality with the creation of a live-in population
